#### **NEW BUSINESS**

#### A. Award fid for 1925 Ohio Street renovations

Director Garvy summarized the memo he presented to the Board, reiterating his opinion that the bid process was very competitive. He reported they have reviewed the scope and submittal from L.J. Morse Construction in detail with them and Williams Architects and feels confident with staff's recommendation.

Mr. Tom LaLonde from Williams Architects reported the tight bids are indicative of tight specifications and clear understanding by the bidders. He explained that it traditionally takes a couple to a few weeks to get all the necessary paperwork completed, bonds pulled, equipment submittals processed and permits secured. He stated during this time the contractor will be able to place orders for long lead items such as HVAC equipment. He reported that so far, all signs are positive.

MOTION: Commissioner Hough moved to award the 1925 Ohio Street Renovation project to L.J. Morse Construction in the amount of \$1,663,500.00. Commissioner Kanzler seconded the motion.

He stated there was great value in the contractors being able to see firsthand the existing conditions and it was important to Williams Architects that contractors have ample opportunity to view the building as they prepared their bids.
