XI.STAFF REPORTS

B. Treasurer, Commissioner Hough, Financial Reports ending April 30, 2016

Treasurer Altpeter reported the numbers are good. Director Garvy pointed out the expenses are a little higher when compared to last April because there were three payrolls this past month and in 2015 it was May with three payrolls. He also reported the District should be receiving some tax revenue in June.

Commissioner Hough expressed her concern with the proposed property tax freeze and the other unfunded mandates imposed by recent legislation. Director Garvy said staff shares that same concern but stated the District is positioned to be able to continue with current levels of service for at least the short term despite the recently changed overtime regulations, minimum wage increases, the impact of the affordable care act, and other unfunded mandates. He credited staff for their attention to controlling what can be controlled as well as the popularity of some of the District's revenue facilities for the ability to maintain current levels of service.
